

## **DISTRICT CITIZEN ENGAGEMENT PLAN SUMMARY**

### **West Lombok District**

#### **District Vision**

There will be sovereignty in the community and civil society organisations including traditional groups, women, children and other marginal groups will be effective and actively involved in every phase of development processes (beginning from planning, implementation through to monitoring and evaluation). The upper stream communities (water catchment and forest areas) and the downstream communities (consumers) will be able to interact and work together in mutually beneficial and sustainable ways. Children will get 12 years compulsory education that is free and of a good quality. Community media will become a channel for control and for pleasure. The organised communities will have mutual respect and value in their efforts to uphold human rights and fulfil economic, cultural, social and political rights. Community elements, the district government and legislature will develop intensive communication. The community will manage their local potential independently. Fishermen, farmers and labourers will have the capacity to improve and access production facilities as well as market networks.

The government will be apt at providing public services to everyone that uphold basic rights, are affordable and of a good quality. The government will provide space for public participation and will be capable of issuing policies that aim to acknowledge, protect and uphold community civil and economic, social cultural, and political rights. Legal enforcement institutions (police, court) will be effective and be based on justice.

DPRD will reflect the community's aspirations and be able to develop policies that are supportive of women, the poor and other marginal groups without discrimination that also incorporate and maintain local knowledge/wisdom.

Natural resource businesses and managers will have a strong social and environmental responsibility to guarantee sustainability.

**Name of Institute : Yayasan Tunas Alam Indonesia (SANTAI)**  
**Title : Capacity Building to Strengthen Community Groups and Local Facilitators to Initiate Local Good Governance in West Lombok District**  
**Program Duration : 3 years**

This action plan hopes to form strong community organizations that are able to oversee the outcomes of the development planning meetings at all levels in the West Lombok district. Community members including women, children, the poor and other marginal groups will participate in all phases of development. This action plan will use strategies involving capacity building for community groups and facilitators, reviewing development planning meeting processes and outcomes, budgeting analysis, strengthening learning and networking between organisations and actors and develop participatory control mechanisms/assessment cards for basic services. This action plan will use a participatory approach and will work in cooperation with village facilitators, facilitator mentors and community organizations. It will strive to contribute to accelerating local good governance, namely, through strong community groups that can participate, plan and oversee development outcomes.

**Title : Develop and Strengthen Community Organisation Access and Control through Community based Natural Resource Management Advocacy in West Lombok District**  
**Program Duration : 3 years**

The main objective of KONSEPSI's action plan is to create strong community organizations that are able to monitor development via sustainable community based natural resource management (water and environment), sustainable environmental management (community capacity building at community forest areas (HKM), community forest gardens (HTR) and forest management groups (KPH), and push for political budgeting processes that are transparent and accountable. This action plan will use a participatory approach and capacity building, strengthening networks, advocacy and mentoring strategies. The program will work in cooperation with village facilitators, facilitator mentors and community organizations. It is hoped that the outcome will enable the community to access and utilize their right to natural resource management via the development of community forest areas/gardens and environmental services. It is also hoped that community organizations and networks will be strong and able to oversee development and make efforts to uphold the education and health rights of women, children, the poor and the marginalized. The capacity building activities, promotion and advocacy for transparent and accountable budgeting processes will contribute to accelerating local good governance by strengthening community groups so they can access and utilize natural resource management rights. This action plan is relevant to ACCESS Phase II by contributing to achieve the core statement in ACCESS Phase II.
